## **Duties and responsibilities:**

- Contribute to a collaborative, solutions-focused culture by working with stakeholders
  to identify requirements using various methods including but not limited to interviews,
  requirements workshops and data and document reviews
- 2. Partner with the business to assess stakeholder needs and solve organisational issues across people, process and platform domains
- 3. Work closely with internal and external stakeholders to ensure requirements are clearly documented, understood and acceptance criteria are well defined
- 4. Apply change management practices to initiatives to increase the likelihood of success
- 5. Prioritise and manage the delegation of work as per the approved budget, schedule and scope to meet or exceed organisational objectives, proving guidance to other staff in the use of the organisation's project management framework
- 6. Coordinate scope definition, project planning as well as cost and time estimating during requirements and design phases to produce accurate estimates
- 7. Accurately forecast, track and project cash flow, authorising project budget expenditure within the agreed delegation limit
- 8. Apply relevant quality assurance practices to ensure deliverables are being completed to standard and project activities are carried out according to best practice
- 9. Proactively manage and apply risk mitigation techniques as necessary
- 10. Produce and maintain IT and project related documentation
- 11. Assist in transitioning projects to operational teams including preparing handover documentation and coordinating handover sessions to ensure true ownership
